"Lvivska Oblast hosts internally displaced persons from all over Ukraine, as most of the western regions do. People require support and coordination, and it relates to access to basic needs and living infrastructure. We are thankful to the M4EG Facility for providing support. There is a fuel shortage; enterprises are moving to the region, health facilities are hosting wounded civilians and combatants, and a vast number of people who fled eastern Ukraine now don't have where to come back and need accommodations. The 'surviving' phase steps into the 'development' phase. Now human resources involved during the first two months are almost exhausted, and we need to put a proper planning and strategic approach," June 2022

#### Introduction

Since the Russian invasion of Ukraine on 24 February 2022, tens of thousands of people have been killed; many Ukrainian cities have been reduced to rubble, and their inhabitants forced to flee.<sup>1</sup> As of 31 March 2023, 8.2 million refugees from Ukraine were recorded across Europe. Within Ukraine, 5.4 million people were internally displaced as of the end of January.<sup>2</sup>

According to Ukraine's second Rapid Damage and Needs Assessment, US\$411 billion is now needed to rebuild and recover from the full-scale Russian invasion. The Russian war of aggression against Ukraine pushed 7.1 million people into poverty and reversed 15 years of development progress.<sup>3</sup>





#### **Immediate Response**

In early April 2022, the M4EG Secretariat in Ukraine reached out to the 144 members of the M4EG network to identify immediate needs related to crisis response and, in particular, equipping temporary shelters for IDPs, as well as local war-affected populations.



Subsequently, the M4EG Secretariat in Ukraine directly supported around 63 local authorities (LAs) in addressing urgent needs of almost 50,000 people affected by the war throughout the year. Moreover, United Nations Volunteers (UNV) Community Volunteers were deployed to provide support to 49 municipalities. These volunteers worked closely with municipal and regional authorities to support crisis coordination, including mobilization and distribution of humanitarian aid to war-affected local populations and IDPs, including food and non-food items, accommodation of IDPs, provision of basic services Partnership and support provided by the UNV Coordinator in Ukraine.



#### **New trajectories**

During August-September, municipalities that were selected for the M4EG programmes Portfolio Journey and Urban Imaginaries re-confirmed their desire and readiness to continue the learning and seed-fund journeys.

In October 2022, the European Union provided a financial top-up under the auspices of the Mayors for Economic Growth Facility to support the crisis's immediate response and recovery & long-term renewal of Moldovan and Ukrainian local authorities, including support to Ukrainian refugees and those displaced by the war, throughout 2022-2023. The new funding programme has 2 lots, 1) Response and Immediate Recovery and 2) Renewal and Anticipation of sustainable development pathways and laid the foundations for economic recovery, future sustainable growth and modernisation of cities and communities.

In November, the European Union and the United Nations Development Programme (UNDP) in Ukraine have announced the official launch of an online course called "Crisis response management of the territorial community and integration of internally displaced persons under martial law." The course is designed for local authorities of Ukrainian territorial communities, including the communities which are hosting the IDPs, and covers a number of thematic areas and aspects, such as legal and theoretical basics, as well as practices and cases of crisis response and further recovery in the social and economic domains.

During the fall, the Lviv city team shared their experience of introducing innovations, running crisis response, and embracing the complexity amid the war. You can read the full article written on behalf of Maksym Terletskyy, acting director of the City Institute, a strategic arm of the municipality and the one behind Lviv's innovations and planning scene here.

Early April was marked with a holistic reflection blogpost based on the experience of Ukraine cities who were part of prototyping the City Learning Circle from October through December 2022. The City Learning Circle is a series hosted by UNDP Regional Center for Europe and Central Asia (RBEC) and powered by Agirre Lehendakaria Center (ALC) and funded by the EU as part of Mayors for Economic Growth Facility (M4EG) — a joint initiative of the EU & UNDP. The City Learning Circle taps into the work of selected cities participating in the City Experiment Fund an initiative under the Slovak Transformation Fund, implemented in partnership with the Slovak Ministry of Finance.

In March 2023, the European Commission and the United Nations Development Programme (UNDP) announced the selection of 13 municipalities from Ukraine under the Call for Local Demonstration Initiatives as part of the EU Response and Renewal Grant Programme aimed at revitalising and supporting the recovery of local economies and communities impacted by Russia's war on Ukraine.

Seven cities were selected under Lot 1 – Response & Immediate Recovery, namely Chortkiv (Ternopil Oblast), Hlukhiv (Sumy Oblast), Kamianets-Podilskyi (Khmelnytskyi Oblast), Slavuta (Khmelnytskyi Oblast), Velyka Oleksandrivka (Kherson Oblast) from Ukraine.

As part of Lot 2 – Renewal & Anticipation, the following 11 cities were selected: Bucha (Kyiv Oblast), Chernivtsi, Kharkiv, Nizhyn (Chernihiv Oblast), Nova Kakhovka (Kherson Oblast), Slavutych (Kyiv Oblast), Velyki Luchky (Zakarpattia Oblast) and Voznesensk (Mykolaiv Oblast).

Throughout April-May, the selected municipalities for the programme went through 4-weeks of learning sprints to validate and strengthen their ideas, receive grants for the activities and participate in the sensemaking sessions to build peer-to-peer learning and explore further opportunities for partnerships.
